(2) Ex. Flyer states "REWARD: \$500 if you return my lost cat." The acceptance of such an offer is the return of the cat, not a promise to look for the cat.

(b) Bilateral Contract

(A) Promise for a promise

(b) If the offeror is asking for a promise in return for his promise, the contract is a bilateral contract.

(1) Ex. A faculty member promises a student he will give him \$15/hr if the student promises that he will become his research assistant.

2. Irrevocable Offer

(i) In General: Offer where the offeror promises to keep an offer open for a specified period of time, and the offeror may not revoke the offer during that time.

(ii) Firm Offer: When an irrevocable offer involves merchants under the UCC, no consideration is required, but the offer must be made in writing, and signed (or on letterhead) by the merchant.

(iii) Option Contract: Under common law, it must be supported by consideration.

B. Acceptance

1. A manifestation of an assent/agreement by offeree to be bound by an offer.

(i) Common Law

(a) Mirror Image

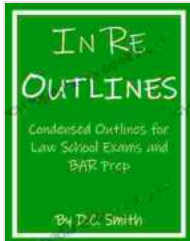
(1) Acceptance must mirror offer, any change in acceptance equals a counteroffer.

(b) UCC

(a) The UCC doesn't require that the acceptance be a mirror image. See 2-207: Battle of the Forms, which allows the offer and acceptance to have different terms. See table below.

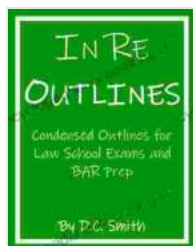

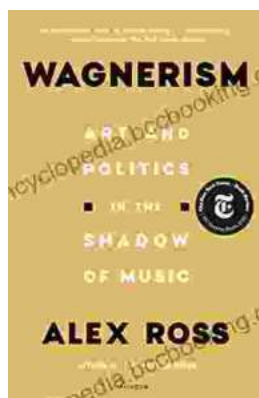
